### 5. PRESENTATIONS

### • 2021 Budget to Actual Final Report –Tracey McKinnon

Ms. McKinnon provided an overview of the 2021 audited budget. The key information highlighted is as follows:

- ➤ A surplus of \$186,000 was transferred to police reserves.
- > The revenue was down \$51,000.
  - Goods and Services were over. This is due to an insurance payment for the replacement of a cruiser.
  - Grants are under budget. This is due to the timing of disbursements by the province.
  - Permits and fines are below budget. The budget amount has been adjusted for 2022.
  - A transfer from Reserves to cover the Alberta First Responders Radio Communications System upgrade
- The expenses were under budget. This is primarily due to staff vacancies and extended leave.

A discussion occurred regarding the balance in Capital and Operating reserves and the IT Reserves for equipment replacement. Ms. McKinnon will provide a report showing the reserve transfers based on a 10-year average at June's meeting.

Chief Blumhagen's report was presented to the Commission as information. No questions or comments arose from the information.

The changes could impact the Commission; therefore, it was decided that a letter would be sent to the Mayor requesting the delay of the review of Bylaw 78 until the Police Act changes are approved.

Chair Gish will prepare and send the letter to Mayor Creasey asking that the review of Bylaw 78 is tabled to a later date.

# <u>Strategic Plan/Key Performance Indicator (KPI) Update</u>

The draft LPS/LPC Strategic Plan and draft KPI were shared with the Commission. The Commissioners were asked to review the information and provide feedback at June's meeting.
