## Request to Access or Correct Information

### Instructions

You can access many public body records without making a request under the *Freedom of Information and Protection of Privacy Act* (the FOIP Act). To determine whether you need to make a request under the Act or if you need help completing the form, contact the FOIP Coordinator, c/o City of Lacombe at <a href="mailto:foip@lacombe.ca">foip@lacombe.ca</a> or phone 403-782-6666.

Written Permission of the Applicant is required to:

- Provide the requested information to a third party;
- Discuss an Access request with another person, including the spouse of an applicant; and
- Release the name of the applicant.

There is an initial fee of \$25.00 that must be paid before a request for general information will be processed. General information is recorded information held by the public body that is not about an identifiable individual.

There is no initial fee for a request for personal information about yourself or about someone for whom you are authorized to act. Personal information is recorded information about an identifiable individual. If you are requesting personal information about an individual that you are not authorized to act for, an initial fee of \$25.00 must be paid before the request is processed.

There can be additional fees charged. A fee estimate and explanation will be provided to an applicant prior to proceeding with the request. If the total cost of processing your request is more than \$150, you are asked to pay a 50% deposit. The records are provided when the fee is paid in full.

#### **Payment Options**

Fees can be paid by:

- Cash, in person;
- Debit card, in person;
- Credit card, in person or call 403-782-6666 if you are paying over the phone;
- Cheque or money order made payable to the City of Lacombe, mailed to the City of Lacombe at 5432 56 Avenue, Lacombe,
   AB, and should accompany a request. <u>Do not include your credit card information in the mail or fax.</u>

#### **General Information Access Requests**

General requests will be emailed to the address specified on this form's front. #### **Personal Information Access Requests**

Please note by submitting this request you are consenting to your personal information being shared with the applicable business unit(s) to assist with the search for responsive records.

Personal information is your own personal information or the personal information of an individual you are entitled to represent.

- You must provide proof of your identity before records containing your personal information are released to you.
- If you are requesting records for another person, you must provide proof that you have authority to act for that person (e.g. guardianship or trusteeship order, power of attorney).
- There is no initial fee for accessing your own personal information.
- If the cost of photocopying is more than \$10, you will be notified of the fee

#### **Continuing Requests**

This is a single request that is processed more than once at predetermined time intervals over a period of up to 2 years. Contact the FOIP Coordinator if you are making a continuing request. The initial fee is \$50.00. You must pay any additional costs as the information becomes available.
